\On 24 Jul 08, 1/26 (12) twelve personnel were detained during a clearance operation in [REDACTED], Basra, Iraq. (4) Four of the detainees were abused during their stay at the Iraqi Police station that was used for the [REDACTED] Headquarters. The abuse of three of the four took place solely at the IP station, and the fourth took place at the IP station and furthermore during his detainment. Injuries sustained ranged from a cut on the head from being hit with a hard object, to severe bruising from repeated blows reportedly from a belt or piece of wood. The stories are consistent with multiple persons using objects to inflict pain and injury located on the back, head, Shoulders and arms. One Eye witness saw the detainees being hit with a belt, fists and feet. At least (8) eight of the detainees had no idea why they had been detained and were only told the IA needed to question them. As of 251030CJUL08 only one detainee had been questioned.\

[REDACTED] REPTS THAT DURING THE DAILY BRIGADE MITT INSPECTION OF THE IRAQI BRIGADE DETENTION FACILITY (IBIF) AT THE IRAQI ARMY COMPOUND AT FOB [REDACTED]-SOUTH, SSG (P) [REDACTED], THE BRIGADE [REDACTED] ADVISOR, DISCOVERED ALLEGED DETAINEE ABUSE BY THE IRAQI ARMY. DURING THE DAILY INSPECTION OF THE IBIF BY SSG WISE AND HIS U.S. CATEGORY 2 INTERPRETER [REDACTED], SEVERAL DETAINEES IDENTIFIED DETAINEE # [REDACTED], [REDACTED], AS ALLEGEDLY BEING ABUSED EARLIER THAT DAY BY IRAQI SOLDIERS (08JUL06). WHEN QUESTIONED, DETAINEE # [REDACTED], IDENTIFIED TO SSG WISE THAT HIS BACK AND ABDOMEN WERE BRUISED AND SHOWED ABRASIONS AND HIS FINGER INJURED. UPON FURTHER QUESTIONING, DETAINEE # [REDACTED] ALLEGED THAT DURING A RECENT INTERROGATION, HE WAS BEATEN AND PUNCHED IN ORDER TO GAIN A CONFESSION. DETAINEE # [REDACTED] ALSO ALLEGED THAT DURING THE INTERROGATION, HE HAD BEEN BLIND FOLDED AND THAT THE [REDACTED] BRIGADE ASSISTANT [REDACTED], CPT [REDACTED], ATTEMPTED TO PULL OUT ONE OF HIS FINGERNAILS WITH A PAIR OF PLIERS. SSG WISE REQUESTED THAT DETAINEE # [REDACTED] WRITE A SWORN STATEMENT, BUT THE DETAINEE REFUSED, STATING HE FEARED FURTHER ABUSE. THE FOLLOWING DAY, ON 090930JUL06, AN UNANNOUNCED INSPECTION OF THE IBIF WAS CONDUCTED BY A COMBINED [REDACTED] TEAM TO EVALUATE DETAINEE OPERATIONS. BRIGADE [REDACTED] PERSONNEL WERE NOT NOTIFIED OR PRESENT FOR THE INSPECTION. THE COMBINED INSPECTION TEAM INCLUDED DR. [REDACTED] A [REDACTED] CONTRACTOR AND [REDACTED] REPRESENTATIVE, [REDACTED], [REDACTED] OFFICE FOR HUMAN RIGHTS, MR. [REDACTED], HUMAN RIGHTS DIVISION OF [REDACTED] OFFICE IN [REDACTED], [REDACTED], HUMAN RIGHTS DIVISION OF [REDACTED] OFFICE IN [REDACTED], GENERAL [REDACTED] (UNIDENTIFIED POSITION), LTC [REDACTED], [REDACTED] ([REDACTED] INTELLIGENCE), AND COL [REDACTED], BRIGADE COMMANDER. THE TEAM WAS LEAD BY A DR. [REDACTED], WHO SERVES AS A [REDACTED] HUMAN RIGHTS MENTOR (HRM). FROM THIS INSPECTION, DR. [REDACTED] ALLEGED THAT THERE WERE SEVERAL DETAINEES WHO APPEARED TO HAVE BEEN ABUSED IN THE PAST (THIS IS CONSISTENT WITH EARLIER [REDACTED] INSPECTION FINDINGS; WHEN

ALLEGATIONS WERE INVESTIGATED, ALL ABUSE WAS DETERMINED TO HAVE OCCURRED AT THE POINT OF CAPTURE). DURING THE COMBINED INSPECTION, DR. [REDACTED] QUESTIONED DETAINEE # [REDACTED], [REDACTED]. DURING THIS QUESTIONING, DETAINEE # [REDACTED], SHOWED BRUISES ON HIS BACK TO DR. [REDACTED]. DR. [REDACTED] BELIEVED THAT THE INJURIES OCCURRED WITHIN THE PAST FEW DAYS. DR. [REDACTED] PASSED THIS INFORMATION TO SSG WISE AT THE END OF THE INSPECTION. DR. [REDACTED] DID NOT TALK TO DETAINEE # [REDACTED], ADDRESSED ABOVE. SSG WISE LATER QUESTIONED DETAINEE # [REDACTED] TO INVESTIGATE THE ALLEGED ABUSE. DETAINEE # [REDACTED] ALLEGED THAT DURING AN INTERROGATION BY SOLDIERS FROM [REDACTED] BRIGADE THE PREVIOUS NIGHT (BETWEEN 2200 AND 2300, 08JUL06), HE WAS BEATEN ACROSS HIS BACK WITH A LARGE STICK. WHEN QUESTIONED, DETAINEE # [REDACTED] STATED HE DID NOT KNOW WHO STRUCK HIM, BUT THAT HIS ASSAILANT WAS "BALDING AND WORE A RED HAT OR BERET." THE DETAINEE REFUSED TO IDENTIFY ANYONE FURTHER. HIS INJURIES CONSISTED OF SEVERAL LARGE BRUISES ON HIS BACK AND RIGHT UPPER ARM. DETAINEE # [REDACTED] WAS DETAINED ON [REDACTED] FOR MURDERING AN IA SOLDIER. SPECIFICALLY, HE STATES THAT THERE WERE OPEN TRENCH LATRINES IN THE HOLDING CELLS IN WHICH LARGE AMOUNTS OF FECES HAD COLLECTED, THAT DETAINEES WERE NOT OFFERED HEAD CALLS BY THE GUARD STAFF UNLESS THEY ASKED FOR THEM AND HAD IN SOME CASES URINATED ON THEMSELVES, THAT DETAINEES WERE NOT OFFERED FOOD AND WATER BY THE GUARD STAFF UNLESS THEY ASKED FOR IT, AND THAT THERE WAS NO STOCKPILE OF FOOD AND WATER AT THE THA, AND THAT DETAINEES WERE FORCED TO SIT, SLEEP AND STAY ON CONCRETE FLOORS FOR UP TO 72 HOURS WITH NO BEDDING, MATS OR PILLOWS.

[REDACTED] THE FOLLOWING ITEMS AND PHYSICAL EVIDENCE WERE NOTED TO BE IN A HOLDING CELL AND ARE CLEAR INDICATIONS THAT HUMAN RIGHTS VIOLATIONS ARE OCCURRING.

EVIDENCE OF UNCHECKED TORTURE WAS NOTED IN THE IRAQI POLICE STATION IN [REDACTED], IZ. LARGE AMOUNTS OF BLOOD ON THE CELL FLOOR, A WIRE USED FOR ELECTRIC SHOCK AND A RUBBER HOSE WERE LOCATED IN THE HOLDING CELL. ENCLOSURES.

ELECTRICAL WIRES THAT HAVE BEEN SPLIT AT THE ENDS AND FIXED WITH MEDICAL TAPE WERE NOTED ON THE FLOOR OF THE CELL. THE TAPED ENDS HAD THE PRESENCE OF BLOOD. AN UNHINGED METAL CELL DOOR WAS POSITIONED AGAINST THE BACK WALL OF THE CELL NEAR THE WIRES. LARGE AMOUNTS OF SPATTERED BLOOD WERE NOTED ON THE FLOOR AND ON A WOODEN PALLET ALSO LOCATED IN THE CELL. A RUBBER HOSE WAS ALSO FOUND NEAR THE STATED ITEMS.

THE POLICE TRANSITION TEAM (PTT) AT CAMP [REDACTED], WHICH IS WORKING WITH THE IPS STATIONED AT THE [REDACTED] IN [REDACTED] IS FULLY AWARE OF THIS MATTER HAVING REPORTED THE EVIDENCE AND IS TAKING THE APPROPRIATE MEASURES WITH THE IP LEADERSHIP TO DO EVERYTHING POSSIBLE TO PREVENT SUCH INCIDENTS FROM OCCURRING IN THE FUTURE.

THE PTT BELIEVES THAT MUCH OF THE BLOOD IS POTENTIALLY ATTRIBUTABLE TO THE SUICIDE VEST BOMBING THAT OCCURRED IN MAY AND AN INDIVIDUAL THAT WAS DRAGGED INTO THAT HOLDING CELL IMMEDIATELY AFTER THE INCIDENT. THE CELL DOOR HAS BEEN FIXED AND THE PTT HAS BEEN SLEEPING OVERNIGHT DURING EVERY PRISONER RELEASE TO ENSURE THAT EVERY PRISONER IS APPROPRIATELY RELEASED.

THE PITT TEAM IS CONDUCTING UNANNOUNCED VISITS TO THE [REDACTED], AND THE DETENTION CELLS HAVE BEEN CHECKED DURING EVERY SUBSEQUENT VISIT AND THE LOGBOOK ENTRIES ON EVERY PRISONER HELD ARE BEING DEMANDED. THE DETENTION CELL OFFICERS HAVE BEEN COUNSELED ON THE SEVERE NEGATIVE RAMIFICATIONS TO RELATIONS WITH THE COALITION FORCES IF HUMAN RIGHTS

ARE NOT RESPECTED. THE HUMAN RIGHTS COURSE FROM THE POLICE ESSENTIAL TASK LIST (PETL) FROM CPATT IS ALSO BEING GIVEN TO THE IP OFFICERS THROUGHOUT [REDACTED]. ADDITIONALLY, THE TASK FORCE MP DETENTION CELLS INSPECTION TEAM HAS PAID THE STATION A VISIT AND INSPECTED THE CELLS AND SPOKEN TO THE IP LEADERSHIP ON THE SUBJECT OF THEIR DETENTION CELLS OPERATIONS.

FOLLOWING A MEDICAL SCREENING BY THE ON CALL DOCTOR, ALL OF THE DETAINEES WERE TRANSPORTED TO [REDACTED] HOSPITAL FOR TREATMENT. Upon receiving detainee [REDACTED]; ([REDACTED]) at the main gate of [REDACTED] AR, the on duty DHA interpreter, [REDACTED], asked the detainee if he had been abused. The detainee stated that while he was detained by CF he was hit with a rifle in the abdomen while in route to the DHA. Once inside the facility and being evaluated by the PA, CPT [REDACTED] DAR [REDACTED] stated he was punched twice in the abdomen. DAR [REDACTED] also stated that his wrist binding were tight and when he complained about them he was hit. DAR [REDACTED] also complained that he was shot with what he believed to be a BB gun. End of incident.

PHYSICAL EXAM FINDINGS: The Physician Assistant (PA) on duty CPT [REDACTED] found abrasions around both wrists where binds were over tightened around the wrist. Welts or noted in the areas he claims to have been shot with a BB gun. One area of Erythema and Edema 2cm x 4cm. Dorsal aspect of left shoulder, 3cm x 4cm Erythematous with Edema right distal of umbilicus.

Exam is consistent with detainee's claims of abuse consistent with welts from an air soft type weapon.
